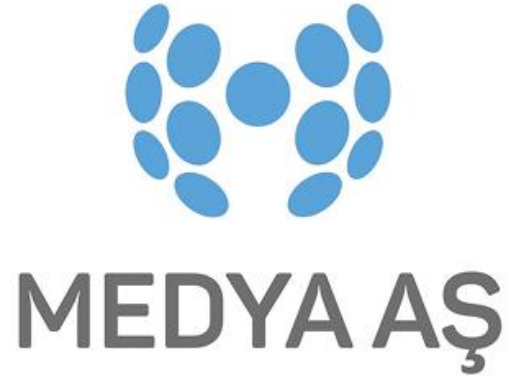

Ekrem İmamođlu, President of UMT and IBB, lives with his family in the presidential residence in Sarıyer, which belongs to IBB. This property, which was previously allocated to a foundation, was given to IBB by Ekrem İmamođlu and organized as a residence so that the mayors after him could also use it. Just like the Florya compound, which was allocated to the mayors of the ruling party before 2019 and contained luxury villas, was allocated to the Istanbul Planning Agency (IPA) on the directive of Ekrem İmamođlu and opened to the use of the people of Istanbul.

"Irregular tenders through Medya AŞ and Kltr AŞ were made, some people were given special jobs; projects or unfinished or left unfinished."



Both IBB subsidiary companies have been repeatedly audited by the Court of Accounts. The rooms allocated to the inspectors were always full and no irregularities were detected in all inspections. Tenders, service procurements and contracts for outdoor advertising media were audited repeatedly. Separate inspections by the Ministry of Civil Administration and Ministry of Trade inspectors did not find any negative findings.

However, the Ministry of Interior has seized hundreds of billions of TL worth of irregularity files that were identified as a result of audits carried out by Ekrem Imamođlu's instructions regarding his predecessor. These files include corruption such as the sale of IBB-owned lands to certain individuals at low prices and their subsequent repurchase by IBB at high prices, scholarships for individuals, private vehicle allocations and expenditures for political activities. However, the fate of these files is still unknown.

IBB, under Ekrem İmamođlu's administration, has faced accusations before and exonerated judicial processes. It was claimed that there were "700 terrorists" in IBB, but only 41 people were tried and were acquitted. The then Minister of Interior admitted these allegations by saying "We had to do it politically". Recruitment at IBB is carried out with great care, and candidates are required to undergo not only a criminal but also a security investigation. No personnel are hired without the approval of the governor's office.

Within the scope of the "Istanbul One Stage" project, which was implemented to support artists during the pandemic, concerts were organized in 3 different categories under the titles Digital Stage, Physical Stage and My Stage Istanbul.

In this framework, a total of 5,535 artists were supported.

The videos and photographs of all events were archived, and detailed information about these concerts was presented to the public in IBB Culture Co.'s 2020-2021 Annual Reports.

16 million people's personal data for advertising and marketing  
companies."



Istanbul Senin is an application where Istanbulites by entering their first name, last name and TRKN information and was put into service in 2022. The user information in the application is opened for use after it is confirmed with Population and Citizenship Affairs Integration. The number of users is currently 3.5 million, not 16 million. In accordance with the LPPD, all users are provided with a disclosure text during the membership phase and their explicit consent is obtained. Personal data processed in accordance with the law are used only by IBB for notifications regarding public services provided by IBB and its subsidiary companies. It is absolutely not possible to sell it to advertising companies or share it with other third parties, except for the provisions of KVKK and the explicit consent of the users.

According to the 2019 and 2024 property declaration of Ekrem İmamođlu, Union of Municipalities of Turkey and Istanbul Metropolitan Municipality Mayor Ekrem İmamođlu and his wife Dilek Kaya İmamođlu, the breakdown of movable and immovable properties registered to them has been shared with the public from open sources.

# İSKİ'NİN YASAL HAK EDİŞ ÖDEMESİ



"General Directorate of Istanbul Water and Sewerage Administration (İSKİ) bank accounts in 2020-2024 unrecorded money amounting to approximately 215 million TL in total transfer was carried out."



The aforementioned company was not given any during the Ekrem İmamođlu period. The payments made are progress payments related to the works during the Ak Parti period. And all of them are legal. İSKİ is a public institution. It is subject to regular audits by the Court of Accounts. Necessary documents have been submitted to the Civil Administration inspectors.
